Support for Recommendation:	A-1 Power Equipment offered an upgraded model that has a stronger & thicker deck and suspension platform. This mower has a 5 year or 1,250 hour warranty and a 2 year unlimited hours warranty. This model is more in line with a commercial grade mower for a minimal increase in cost to the downgraded model. We believe we will get more longevity out of this model as this mower is used daily at all common areas.
