In summary the Bylaws dictate

that: (a) The annual elections meeting be held on the last Saturday of each April.

(b) That four Board seats are up for election in even numbered years; three seats in odd numbered years.

(c) That members serve for two year terms and may only serve for two consecutive terms.

(d) That the only qualification for members of the Board is that they be voting members (property owners) in good standing.

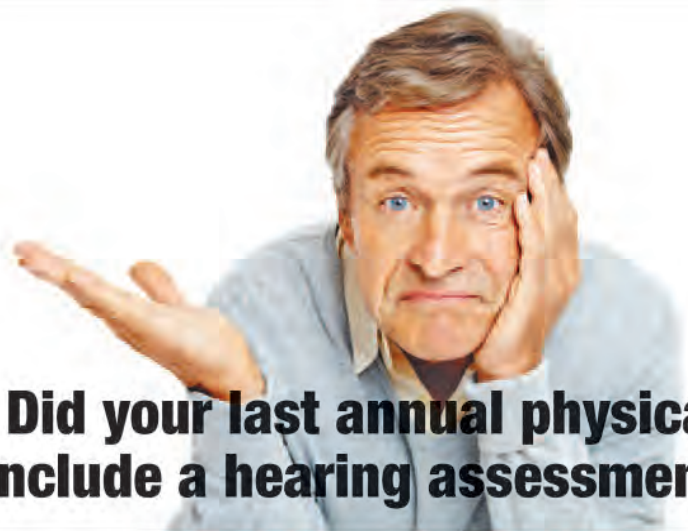

PACKAGE POACHING



During this time of year a lot of residents will be ordering items online and having them shipped to their homes. This is also a prime opportunity for thieves

to steal the packages from your doorstep or porch. Thieves can follow delivery trucks, watching for prime targets. These thieves commonly strike during working hours as many homes are empty at that time. Here are some steps you can do to avoid having your package stolen.

1. Choose a shipping option so you have to sign for delivery (and tell friends and relatives who may be shipping you packages to do the same). If you can specify that only the person whose name is on the package sign for it, make that happen.

2. Keep an eye on the package's delivery status so you know when to expect it (then you can either be home or leave a note for the delivery person to deliver it to a neighbor). If friends/relatives are sending something, ask them to send you the tracking number.

3. Get to know your carriers. Typically they have the same person on 'your route'. Introduce yourself and get to know them when possible. Having a connection to who is delivering your packages will help get better service. If there has been a problem with stolen packages in your neighborhood, tell them about it.



4. Ship the package to another location if you aren't generally home such as your office or a neighbor/friends' home. (Check with work to make sure this is allowed.)

5. Leave special instructions where to deliver packages if you are not going to be home.

6. Choose "delivery pick up" so they hold your package rather than leave it on your doorstep.

7. If you live in a building, set up a way to have neighbors hold each other's packages rather than leave them in a common area.

8. Insure your packages just to be safe. 💎

CODE ENFORCEMENT



It's time to put away all the Thanksgiving leftovers, and start digging out the Christmas decorations. Remember last year how you were in a hurry to put away the lights, and now they're a tangled mess? By the time you get them up and lighted, it will be worth all the effort and aggravation. What's holiday time without bright lights and all the fun stuff to look at.



Along with the up down weather we are having, we've had some pretty good winds. Every year we receive calls about the clean-up of leaves and pine needles that do not belong in their yards. I wish we had a solution to this problem, but we do not. There is no way to control where the wind blows any of the leaves. We always suggest that homeowners talk to each other and try to work out a plan to help each other with the issues. The owner with the tree should do their best to help the one that is getting their tree debris.



Should you find yourself under the mistletoe this year, you are enjoying a long time custom. Mistletoe is seen as a symbol of peace. It is said that among the Romans, enemies who met under mistletoe would lay

down their weapons and embrace.

Scandinavians associated the plant with Frigga, their goddess of love, and it may be from this that we derived the custom of kissing under the mistletoe. Those who were kissed had the promise of happiness and good luck in the following year. If you're kissed under the mistletoe, enjoy the happiness, but should you see mistletoe in your trees....it is the kiss of death!

Mistletoe is considered a parasite and trees that are heavily infested by this plant for several years may be reduced in vigor, become stunted, and die. Mistletoe depends on the host plant for water and nutrients. Trees that are infested with this plant will weaken as time passes. Should you want further information on this plant, search the internet or contact an Arborist for advice.

With the holidays coming, many families and friends will be coming to visit. Please remember that vehicles, boats, 5th wheels, and motorhomes can only be parked in your driveway for 72 hours. Please also have consideration for your neighbors and residents when parking those larger vehicles on the street.

While we're talking about vehicles, we need to bring up an issue that came up during a meet-

ing with the California Highway Patrol and homeowners here in our community. Are Big Rigs or 18 Wheelers being allowed in Spring Valley Lake? The answer is **NO!!!** There are signs at 3 entrances to our community that state: **NO PARKING COMMERCIAL VEHICLES 5 TONS GROSS WEIGHT OR OVER.** According to CHP, the only time a vehicle of that type should enter here is to make a delivery. The officer stated that should we ever see one parked on the street, to call their dispatcher. Residents should make note of the following number and do the same: CHP Dispatch (760) 241-1186 or in the evening (760) 256-1617.


SVL Architectural Policy 10.4.2 States Storage of Commercial equipment/vehicles is prohibited on residential lots.

It has come to our attention that some properties in the

Equestrian area have OLEANDER plants in their yards. These types



of plants are not allowed due to their danger to horses and other animals if ingested. Other plants not allowed are, Japanese Maple, Yew, Ground Ivy, Chokecherry, Wild Cherry, and Black Locust. If you have any of these plants, they must be removed immediately. We do not want any harm to come to the horses or any of your pets.

We just celebrated Thanksgiving and we are VERY Thankful for the many homeowners that work hard to keep their homes and yards so nice. It is YOU that makes our job worthwhile, and gives us the patience to deal with properties that are not up to code. Thank you again for caring about your home and Spring Valley Lake.

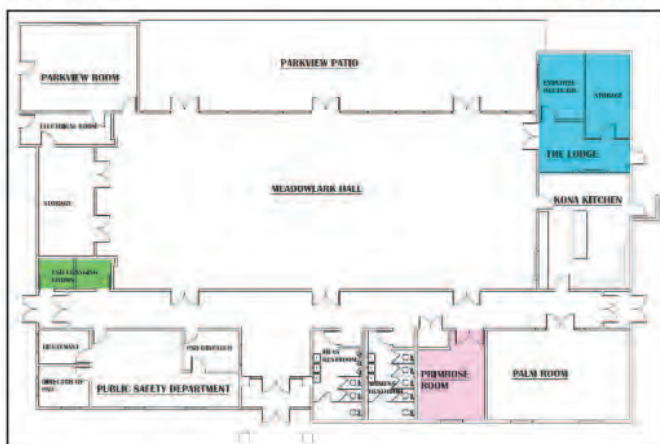

The CSD Exploratory Committee has been formed to investigate the viability of changing CSA 64 (Community Service Area) into CSD 64 (Community Service District). CSA 64 is managed and operated by the Community Services District department of the San Bernardino County. Changing to a CSD would put the control, focus, management and decisions with a newly formed board of those residing in our district.

The current CSA 64 is all of Spring Valley Lake continuing out to Bear Valley, the SVL Equestrian area, the commercial area at the northwest corner of Apple Valley Road and Bear Valley and a small part of Apple Valley along the Mojave River.

The process to make this change is very detailed and includes the following:

- Completing a feasibility study that must be signed off by both LAFCO (Local Area Formation Commission) and the County Board of Supervisors.
- The Feasibility Study is very detailed and if not realistic will not pass LAFCO
- After those approvals it will go out to the residents of our Service Area for Vote.
- There are two votes: First a yes or no for creation and second for a Board of Directors.

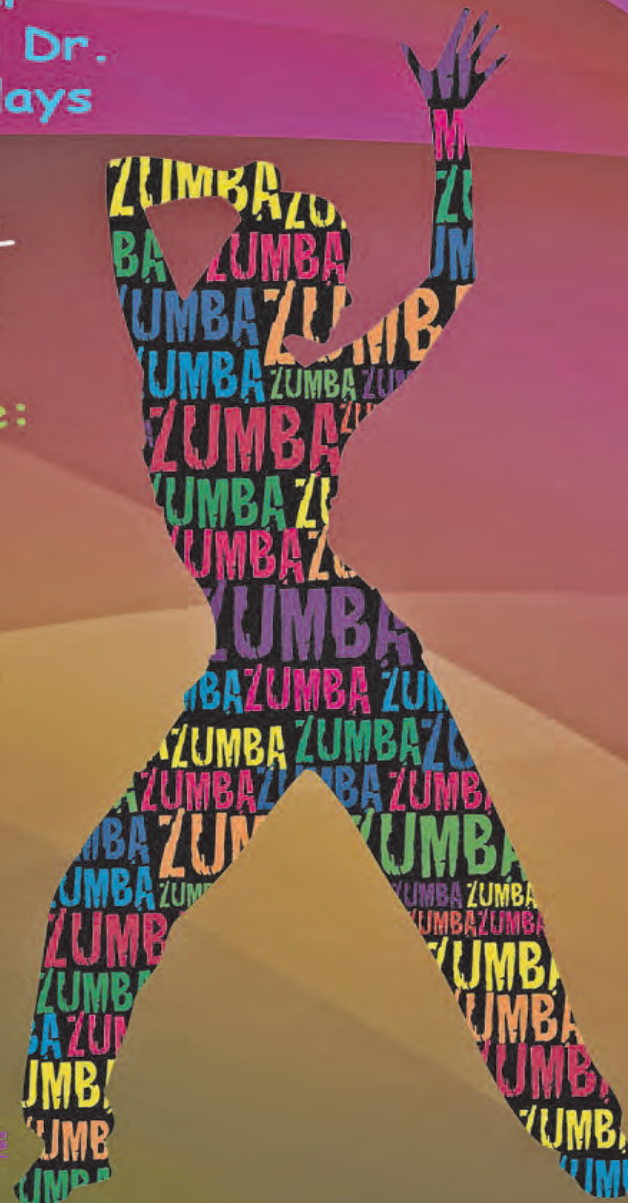
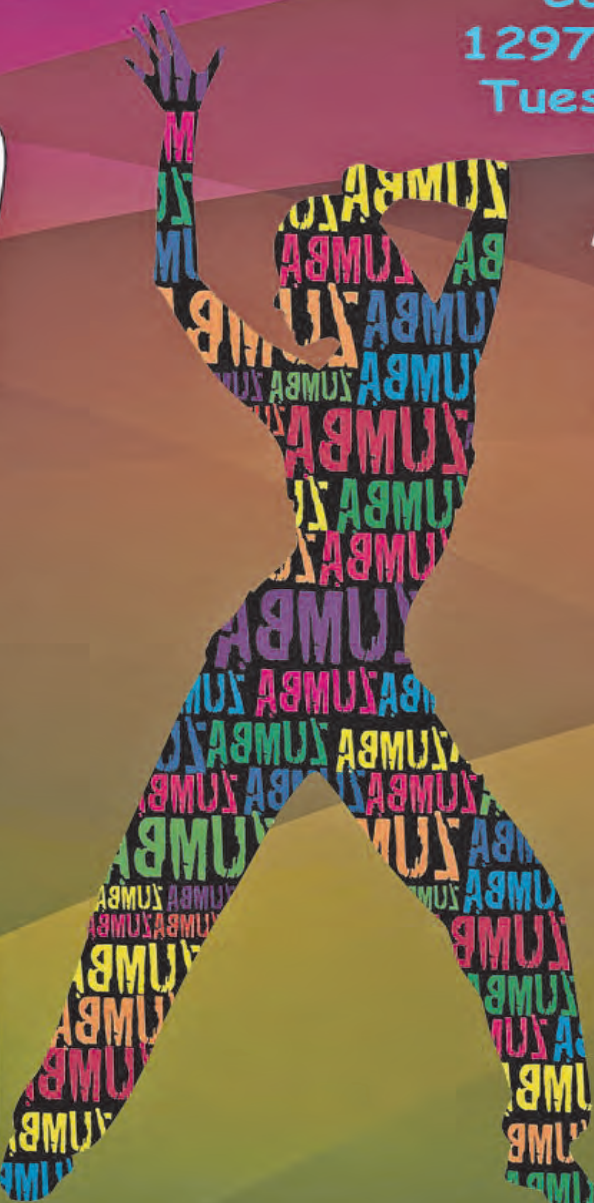
