

I am sure that many of you have questions about this "Rule #3" that has been proposed. Let me try to help answer your questions.

#### How did we get here?

In 2013, the SVLA Board of Directors created the "Community Task Force" in an effort to search out opportunities or issues to take on as a project to bring recommendations to the Board. Soon after that, the Task Force was formed with members and a chairperson being approved by the Board.

### Why non-owner occupied properties?

When the Task Force first met, several meetings were dedicated to determining what issue we would tackle. After much discussion and validation with the community, the issue of non-owner occupied properties was chosen. While that was a very broad topic in the beginning, the focus changed in time to poorly managed properties/renters and the increasing percentage of non-owner occupied properties in our community. Let me speak to both:

### High percentage of non-owner occupied properties:

As a private community, our interests lie in the community and the interests of the owners. Landlords/investors have clearly differ-

ent interests than those that live in and occupy the properties in the community. Landlords are interested primarily in cash flow and appreciation. Owner Occupants are interested in the quality of life in the community, amenities, property values, appearance and safety. This percent has grown in time to approximately 33%. Industry experts all agree that "owner occupants" tend to care for and invest more in their properties. This translates to a better appearance in the community. In addition, owner occupants stay in their properties longer and create more and longer lasting relationships in the community.

This would be a good time for us to explain that renters are not bad people and in no way is the association disparaging those that rent. It is just a fact, that as a rule, owner occupants spend more on their properties in terms of upkeep and improvements than landlords.

Another concern with an increasing percentage of landlords is that voting in favor of association improvements becomes more difficult. As landlords are more interested in cash flow than improvements, it is concerning as the number grows closer to 51 percent being non-occupant owners. In fact, many say that the number

of concern could be closer to the low 40's than 51%. In a vote that might benefit owner occupants, a smaller number of landlords could swing the election as a higher percent of them would vote.

Anyway, industry experts all say that a high percent of non-owner occupied properties is not good for any association.

#### How does "Rule #3" help?

First, by only allowing owners who have lived and owned here for a year to rent properties, we will have eliminated those "out of area" landlords that have no emotional attachment to our community. It has been clearly documented that owners that live/lived in the community better manage their properties than those that have not lived here.

Second, by eliminating a certain number of non performing

landlords from the potential buyers' pool, we will in time reduce the percentage of non-occupant homeowners to an acceptable level. This will not impact any owners that live here in any way. In the event of another downturn in the market, those out of area investors will be blocked from gobbling up properties and those opportunities will go to owner occupant buyers and those that currently live and own in the community.

Rule #3 is a very strategic move for our association to protect our community from the trends in the High Desert and other markets of increasing non-owner occupied properties.



#### Why Do Vessels Sink?

As most of you know, the number of vessels that took on water/ sank has recently been a common discussion topic. Most residents' first reaction is that the bilge pump was not properly working. What really needs to be investigated is where did the water come from and why? The truth is that your bilge pump often hides the actual problem that can be detected by implementing a good preventive maintenance procedure. As a result, your problem will not be identified until the pump gets clogged or the battery goes dead. Preventive maintenance is essential to avoiding an issue. We wanted to bring this topic to your attention so that you can make an effort to prevent it from happening to your vessel. After doing some research, here are a few facts and ideas to help you out:

- From the Boat U.S Marine Insurance survey it was determined that Underwater Fittings accounted for 50% of the causes of water leaks and the boat filling up with water.
- Preventative maintenance can be the best defense in preventing boats from filling with water and sinking at the dock.
- Rain and Snow accounted for

32%, Fittings above the Waterline for 9%, Poor Docking Arrangements for 8% and 1% for Other.

- Inboard-outboard powered boat owners should inspect sterndrive bellows on an annual basis. It is recommended to replace it every three to five years. The shift bellows is usually the first to fail, according to Boat U.S.
- Boaters who own inboard powered boats should check the stuffing box every time they visit the boat, and repack every spring, rather than simply tightening down the nut.
- Replace the engine cooling system impeller approximately every two to three years.
- Always check your vessel before and after a storm.
- Don't forget to check the drain plug!

The Public Safety Department also wants to be clear that it is the vessel owner's responsibility to remove their vessel if it capsizes. The best thing to do is to be proactive and come up with a procedure /plan in the event that you come across this issue. Be sure you check with your vessel insurance company so you know exactly what your policy covers. Contact-

ing a vessel recovery company can be expensive. I recently contacted a local well known insurance company and they were very hesitant to give direct answers due to the fact that every policy is different. What I did learn is that each case is looked at separately and if you fail to properly maintain your vessel or negligence in maintenance is discovered, you may not be covered. In conclusion, be sure that

if your vessel is docked in the water that you are implementing a proactive maintenance schedule recommended by your mechanic. Your insurance company can provide you with a list of vessel recovery companies that service your area. Check with your insurance company to know your options/coverage and have your plan ready in the event you come across an issue.




## The Coffee Break Salutes Brennley!



Much progress has been made on the Meadowlark Park project. During the March Board Meeting, General Manager, Glenn Grabiec, reported from the association legal sources that there would be no increase in association premiums due to the construction of an off leash pet area and no increased liability to the association. The only stipulation would be signage rules governing the area as posted in other community dog parks. This is the news we have been waiting for to move this project forward. During the February Board meeting, President, Steve Garcia, expressed his concerns that the park would get started, then, due to construction decisions, time constraints (for SVL Little League) or funding issues, the park would remain unfinished.

The directors completed their design input, the legal team has reported, and Director of Operations, Dennis Teece, is finalizing the specific costs. These are huge moves towards easing the concerns of the Board President and all members; with the end results being a beautiful park where members can meet for a safe out of the road walk, let their dogs play off leash and SVL Little League families can experience well laid out and safe fields as well as viewing areas. We currently experience a fine beach, beautifully landscaped and planned fishing areas, an equestrian area unlike any other in the High Desert communities, as well as our SVL Community Building design. It's time our parks are brought up to those same standards. Stay tuned.





At last....on March 12th we got to Spring Forward!!!! Daylight Savings time means we

get more light. That also means Spring is finally in the air, and winter may be leaving us. Winter sure has brought us a lot of moisture this year, but we needed the rain here in the High Desert.



What the rain has also done, is given us a new bumper crop of weeds in our yards.

Weeds are something we all deal with continually, and we never seem to get ahead of them. Their seeds are carried by the wind, animals and humans, and grow when the temperatures are right for them. They can hide in the fertilizer and plants you use in your landscaping.


get rid of the pesky things? Here are some suggestions that may work for you. Birdhouses should not be positioned in lawn areas, as birds drop seeds on the lawn. Any plants that you purchase for planting should be checked for weeds and. When you pull the weeds, do not leave them on the lawn or ground, as they can seed and grow again. The best suggestion we can offer is to apply a good herbicide that will prevent weeds from growing, but will not stop rooted lawns from growing.

A strong and healthy lawn can often stop weeds from growing. Aerating your lawn is good for its roots, and makes it more difficult for weeds to grow. Mowing often with a high blade keeps your lawn thickness higher, allowing the lawn to use the resources weeds need to grow. Watering in larger amounts every few days is better than watering every day.

Should you have weeds already in your landscaping, use a good herbicide that will kill the weeds, but not harm the grass. If you have a gardener, they should be well educated in dealing with most of our common weeds here in our community. Whatever methods you use to control the weeds, we hope you are successful in the coming weeks of spring.

While we're talking about The question is...how do we weeds and lawns, we want to cauthe backyard if at all possible. If you need to plant herbs, try planting them in pots and not your rock areas. It becomes hard to tell them from the weeds; and your rock areas should be free of all weeds. and vegetation.


