# 2021 VESSEL REGISTRATION....

## BEGINNING DECEMBER 1, 2020

**Vessel Stickers are valid from January 1 to December 31 of each year.  
All vessels must be re-registered each year.**

Vessels can be registered from 7:30 a.m. until 5:30 p.m., Tuesday through Friday. All **NON-POWERED vessels** (kayaks, canoes, paddle boats etc.) as well as **POWERED vessels** must be registered prior to entering the lake. If any vessel found on the lake is not registered, the owner will be cited and fined for each vessel in the water. The following requirements are necessary to register your vessel with the Association Office.

### VESSEL REGISTRATION REQUIREMENTS:

All Documents (DMV Reg., V.O.P., Ins.) **MUST list the same Homeowner/Tenant Member's name.** The Association office will need copies of the following: V.O.P, Driver's License, DMV Registration, Insurance, Safety Inspection and Signed Conditions form.

**1. Yearly safety inspection.** All powered vessels must pass a safety inspection by our Public Safety Department. You may call and schedule an officer to come to your home or bring the vessel directly to the launching ramp. Please remember to **make an appointment prior to bringing the vessel to the marina.** Other than sailboats, all non-powered vessels do not require a safety inspection. **The inspection will include a review of the following:**

- Current DMV registration, listing the hull number, make and model of the vessel
- State registration numbers properly displayed with certificate number when applicable
- Sound signal devices, visual distress signals, lights, ventilation systems, flame arrestors, water ski flags, fire extinguishers, and personal flotation devices
- Inspections will include check for Quagga Mussels
- **Please contact the Public Safety Department at 760-245-6400 with any questions**

**2. Current Driver's License listing the HOMEOWNER or TENANT Member's name.**

**3. Current SVLA Operator's Permit.** An operator's permit is **required** for all Homeowners, Tenant Members, and their guests driving powered and non-powered vessels. The Public Safety Department administers the test daily at 9 a.m., at the Community Center. You may also take the test online at [www.svla.com](http://www.svla.com). Click on **Departments**, click on **Public Safety**. Contact Public Safety when completed. Study guides are available at the Association Office and online. Public Safety will need your current Driver's License, your SVL member card and, starting December 2021, your CA Boater Education Card to issue a V.O.P. (See handout for info regarding the **CA Boater Card**)

**4. Current State DMV Registration.** The registration must include the homeowner's or associate member's name and address.

**5. Current insurance policy.**

- **Powered vessels must** provide the following:

- a. Name of the homeowner or tenant member
- b. Policy number
- c. Policy period **must** include beginning dates
- d. Vessel hull and CF number
- e. Spring Valley Lake Association **must** be listed as

**Additional Insured or Additional interest**

g. \$300,000 minimum liability

- **Non-powered vessels must** provide the following on homeowners policy:

- a. Name of the homeowner or tenant member
- b. Policy number

- **SVL Staff members cannot inquire for you.**

Insurance companies will **ONLY** provide information about individual policies to policy holders.

**6. Payments and stickers.** Payments are taken and stickers are issued **after** all the above requirements are met:

- Non powered vessels \$0.00
- Powered vessels 15 horse power and under \$50.00
- Powered vessels over 15 horse power \$155.00

**Vessel Stickers are not prorated.**

For any questions, regarding the above information please contact the Association office at 760-245-9756. Please register your vessels early and take full advantage of our beautiful lake.

**Friday is our busiest day for boat registrations.** Please consider an alternate day to save both waiting time and frustration. Call our office prior to registering. We will gladly provide you with a personalized list of your requirements.

# The Kitchen Diva!

## Aromatic Holiday Gifts From the Kitchen

Gifts from the kitchen are easy and inexpensive to make and are always welcome during the holidays.

Sachets and potpourri make beautiful and aromatic Christmas gifts. They can be fashioned from a variety of herbs and potpourri, and are simple to make. Bath sachets can be put directly into the tub or tied to the faucet so that the hot water passes through the herbal mixture as the bath is drawn.

Sachet bags also may be placed inside clothes drawers, tucked into the corners of couches or armchairs, or placed inside of closets to freshen up a closed space.

Any number of creative and inexpensive combinations may be used to make potpourri. Spices, flowers, essential oils, your favorite perfume, dried herbs and citrus peels all make a wonderful potpourri.

Using a fixative — such as a tincture of benzoin, styrax or orris root — will extend the life of the perfume and ingredients. Most fixatives can be purchased at craft stores or ordered online.

These easy-to-make recipes for bath sachets, potpourri and an herbal rubbing lotion will be fragrant reminders long after Christmas is over. Remember, gifts from the heart are part of the true meaning of Christmas. Have a happy holiday season!

### BATH SACHETS

- 2 cups dried herbs (lavender, sage, rosemary, pennyroyal, lemon verbena, chamomile,

thyme or mint — alone or in any combination)

- 8 (4-inch) squares of cheesecloth or cotton (8 small decorative handkerchiefs also work well)

- 8 (12-inch) lengths of ribbon or lace

1. Place the herbs in a plastic bag. Roll a rolling pin back and forth over the herbs until they are slightly crushed. Place 1/4 cup of the dried herbs in the center of the cloth square.

2. Gather the square in a pouf and knot a piece of ribbon or lace around the neck of the pouf to secure the herbs. Make ribbon or lace into a bow, leaving the ends long enough to tie the bath sachet to a faucet. Makes 8 bath sachets.

### ROSE PETAL POTPOURRI

- 3 cups dried rose petals
- 2 cups dried lavender
- 1 cup dried lemon verbena
- 1 tablespoon dried lemon peel
- 1 tablespoon allspice
- 1 tablespoon cinnamon
- 1 tablespoon cloves

1. In a large jar, combine the rose petals and lavender. In a medium bowl, mix the lemon verbena, lemon peel, allspice, cinnamon and cloves. Pour the lemon mixture into the jar containing the rose petals and lavender.

2. Cover jar tightly and shake ingredients. Let potpourri stand for 2 to 3 weeks, shaking mixture frequently to combine the scents.

### To give as gifts:

- 8 small drawstring bags or 8 (4-inch) squares of cheesecloth or cotton (8 small

handkerchiefs work well)

- 8 (12-inch) lengths of ribbon or lace

Place the potpourri in a decorative bag with a drawstring, or to make a sachet, place 1/4 cup of the potpourri in the center of a cloth square. Gather the square in a pouf and knot a piece of ribbon or lace around the neck of the pouf to secure the potpourri. Make the ribbon or the lace into a bow. Makes 6 cups.

### HERBAL RUBBING LOTION

This is refreshing herbal lotion is a wonderful pick-me-up for sore muscles and tired minds at the end of a long day. The herbs also give the rubbing alcohol a pleasant fragrance. The herbs may be obtained from grocery stores or online sources. You also can purchase decorative bottles online or from craft stores.

- 1 cup fresh lavender leaves
- 1/4 cup lemon verbena
- 1/4 cup mint leaves
- 1/4 cup rosemary sprigs
- 2 cups unscented rubbing alcohol

1. Place the herbs in a plastic bag. Roll a rolling pin back and forth over the herbs until they are slightly crushed to release the oils and fragrance.

2. Place herbs in a glass jar that has been sterilized by boiling. Add the rubbing alcohol. Cover tightly and label the jar NOT TO BE USED INTERNALLY. Set aside in a cool, dry place for 5 to 7 days. Strain the alcohol through several layers of cheesecloth into pretty jars or bottles.

3. Cap tightly and label bottles or jars, NOT TO BE USED INTERNALLY. Tie a pretty bow around the bottles or jars, if desired. Makes 2 cups rubbing lotion.

## Keeping Busy This Winter

Winter is fast approaching, but at least we're no longer getting those constant election phone calls, and the endless calls about signing up for a Medicare Advantage Plan have ceased. The one thing that hasn't gone away is the coronavirus, and our lives are nowhere back to normal. After we've baked yet another loaf of pandemic bread and can log on to a Zoom neighborhood chat with our eyes closed, it's time to look for other things to do.

Here are some of the things I'm checking into to stay busy (and indoors) this winter:

— **Becoming a remote reading tutor for a child.** This would be done via the school's chat program, so there's no risk of transmission of the virus. A school aide will send me links to copied pages of books that my assigned child is learning to read, and we'll hook up while he or she is at school.

— **Growing plants with grow lights.** I've arranged shelving in a spare room with space for plenty of plants, both houseplants and herbs. The plan is to have a mixture of small houseplants such as pothos and spider plant, and give them as gifts to neighbors once they are big enough to divide. — **Experimenting with pottery.** I've been curious about air-dry pottery, so I've ordered 10 pounds of white modeling clay and a smaller package of terra cotta. The reviews say it's good for sculpting and doesn't require a kiln or baking in the oven. If it works, I'm thinking of creating jewelry and painting them with acrylics or trying to produce miniatures of famous sculptures from museum websites. (Rodin's "The Thinker" seems appropriate right about now.)

These projects should keep me busy over the winter. How about you?

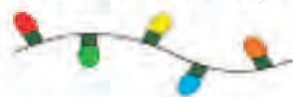
ert" and the most desirable place to live.

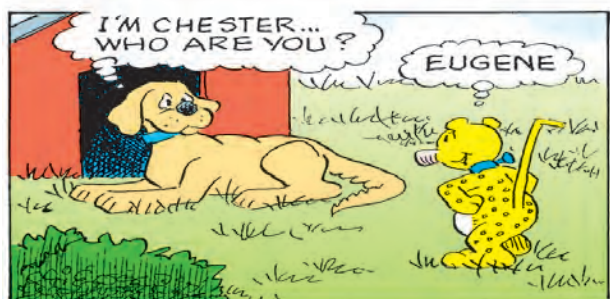
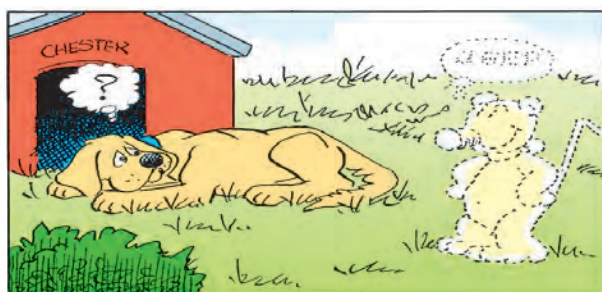
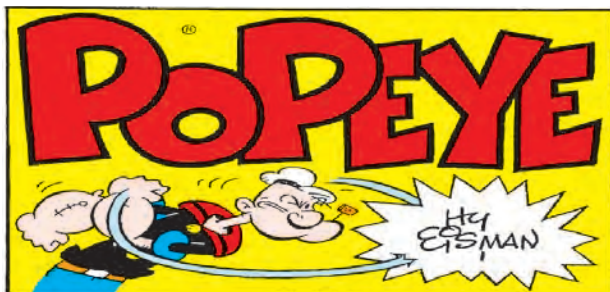

## Rosemary Cashews for Holiday Giving

Before COVID, my holiday traditions this time of year began with a gathering of five neighborhood friends for an early-morning coffee klatch at one of our houses. We originally met when our sons were just 5 years old, and our friendship continued through Cub Scout activities, softball games, bike rides and picnics at the neighborhood park. Off they went to college, and we attend their weddings together.

Since we still lived within blocks of one another, we'd take turns hosting the annual get-together. For the one in charge, it offered an opportunity to use our fanciest or quirkiest tableware for serving fruit, pastries and coffee. We'd exchange little memorable, sometimes homemade, gifts, too. I liked to bring something from my kitchen, like this rosemary cashew appetizer/snack I prepared last year.

The tasty cashews were such a hit, I decided to make the recipe in multiples this year and fill wide pint-size canning jars I picked up at the store. Tied with holiday ribbon, gift tags and a shiny mini-size gold ornament for extra bling, it is a unique, personalized gift.

Make these in an afternoon with your school-age kids, who can assist in doing a step or two. For starters, let them take charge of pulling the fresh rosemary leaves off the stems before you chop the fragrant herb with a sharp knife. Then

put the kids in charge of decorating and writing the tie-around gift tags.



### ROSEMARY CASHEWS

- 3 cups roasted, unsalted cashews
- 1 heaping tablespoon minced fresh rosemary leaves
- 1 tablespoon brown sugar
- 1 tablespoon salt
- 1½ tablespoons unsalted butter, melted
- 1/4 teaspoon cayenne pepper (optional)

1. Heat oven to 350 F.

2. Spread the cashews in one layer on a cookie sheet and bake for about 6 minutes, or until warm and lightly toasted.

3. Combine the rosemary, brown sugar, salt, melted butter and pepper (if you want an extra kick) in a large bowl. When the cashews are heated, immediately pour them in the bowl with the spice butter mixture. Toss thoroughly.

4. Cool and serve. Store in an airtight container up to two weeks.

NOTE: If you prefer, substitute 1 tablespoon pure maple syrup for 1 tablespoon brown sugar.

THE HISTORY CHANNEL

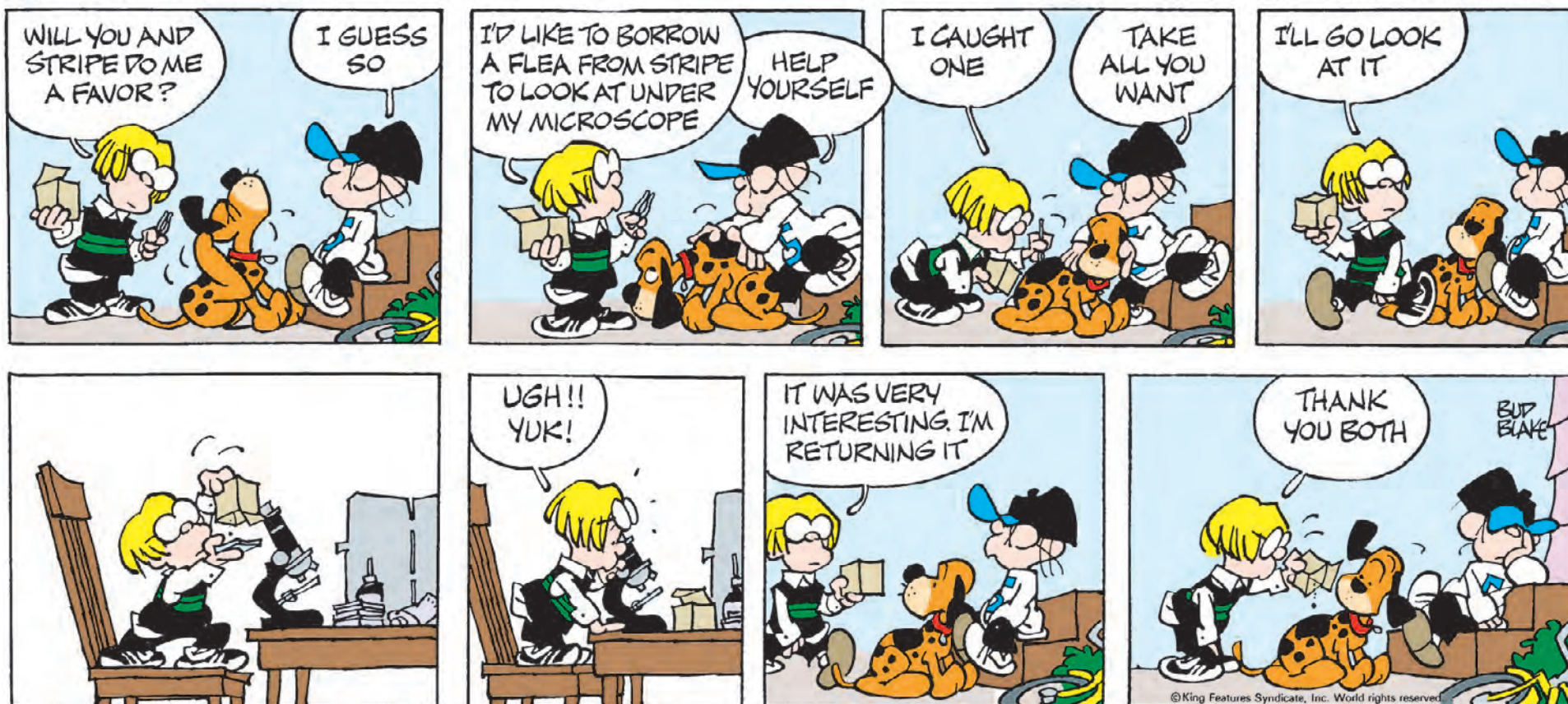

### PART III

After issuing a compliance request or notice for the same violation twice, the third violation will result in a citation, if the same violation has occurred in a one year period from the date of the first violation.

### PART IV

In accordance with article III, Section 5.2 of the Spring Valley Lake Association Bylaws, any fine that is not satisfied within ninety (90) days after it becomes due and payable can result in the loss of the rights of use and enjoyment of the recreational common areas and common facilities of the Spring Valley Lake Association.

## Questions About COPD

**DEAR DR. ROACH:** I was diagnosed with COPD a year and a half ago and have several questions. I seem to be unable to get answers from my pulmonary doctor, as he is always busy and doesn't have a lot of time to spend with me.

How fast does COPD progress? I'm 78 years old, in reasonably good health and exercise regularly. I have chronic bronchitis with a slight amount of emphysema. I had been coughing a little during the day, had mucus in the morning and coughed at night for two to three hours after bedtime — to the extent of having to use a rescue inhaler to settle down and get back to sleep. After he put me on Trelegy, all of those symptoms disappeared, and I feel perfectly normal except for shortness of breath.

My other question is what is the life expectancy of a person diagnosed with COPD? I've read about answers to this all over the map, from two or three years after diagnosis to 15 or more years. I would presume that it depends on other factors such as physical condition, exercise, weight, etc. But I would like some kind of guideline for someone in my condition. — *T.J.*

**ANSWER:** There are two major types of chronic obstructive pulmonary disease: chronic bronchitis, where the primary problem is productive cough; and emphysema, which is destruction of the small airways. Shortness of breath is a common feature of all types of COPD. The most prevalent cause is smoking.

I can't answer your questions on rate of progression and overall prognosis without much more information, but it

is certainly a good sign that many of your symptoms are well-controlled on treatment. The single biggest factor in rate of progression of COPD is whether you are a smoker, but not being able to exercise, being male and being very underweight are additional risk factors for faster progression.

Lung function falls inexorably over time. In people who have no lung disease, the normal decline with aging is never enough to cause symptoms during normal activity. In someone with COPD, the decline over months to years can cause symptoms to occur first with exercise, and then when at rest. Once people have severe symptoms at rest, the prognosis becomes quite poor.

No medication can reverse lung damage. Inhaled steroids reduce inflammation and can slow progression somewhat. Inhaled bronchodilators open airways and make breathing easier. Inhaled anticholinergics reduce secretions. Your medication, Trelegy, contains all of these medicines, and is appropriate for people with severe COPD or those who do not have good symptom control with a less intensive regimen.

An online calculator for prognosis can be found at <https://bit.ly/2N1UEoy>. It can be used if you know how far you can walk in six minutes and the results of your breathing test (specifically, the FEV1%).

**DEAR DR. ROACH:** After reading your recent column on mercury, I wonder how dangerous mercury amalgam for cavity fillings is. I'd guess that the amount of metallic mercury ingested is insignificantly small and of no consequence to overall health. But is it better to replace that type of filling with newer, less-toxic fillings? — *J.G.*

**ANSWER:** Many studies have looked at potential health harms to dental fillings using mercury-containing amalgam, and the consensus is that they are very safe, and that there is no good reason to remove them.

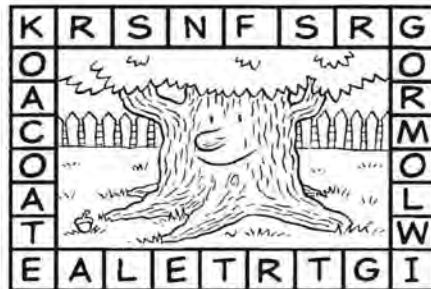
