SECURITY DISCLAIMER

The Spring Valley Lake Association (“SVLA”) is a nonprofit corporation formed to manage and maintain all property owned by it and/or under its control. In connection with those responsibilities, the SVLA Public Safety Department (“PSD”) has as its core purpose the protection of the SVLA common area amenities. The work it performs generally includes observing and reporting from public streets and SVLA common areas to enforce the Association’s rules and other governing documents. Please note these are not law enforcement efforts, nor do the PSD patrol personnel function in the capacity of “security guards”. Rather, the PSD’s enforcement efforts are tied to the enforcement of the SVLA governing documents that preserve the ability of SVLA residents and guests to enjoy the SVLA common area amenities.

Neither SVLA, its PSD, nor any of their respective employees, directors, officers, agents, or contractors have any obligation under the Association's governing documents or the law to provide for the security of those within SVLA. SVLA is not a law enforcement entity, nor is it responsible for protecting people from third-party criminal conduct. While the presence of PSD personnel may assist in deterring crime, as well as the reporting of incidents to local law enforcement, that is not their focus.

Members and residents are ultimately responsible for protecting themselves and their property from criminal conduct. It is not reasonable to rely on the PSD to do so. Any concerns regarding potential criminal activity that may be taking place within SVLA should immediately be reported to local law enforcement. 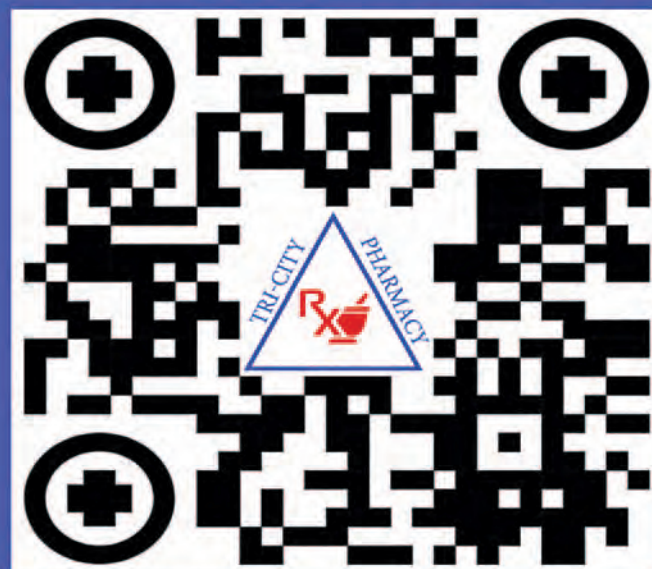

Stay tuned for announcements about activities that will make this season memorable for all. SVLA summers always bring a lot of fun and always make sure to keep us busy. Look below to see what we have been up to over the last month...

Beach Area:

- Our Beach treatment continues Every Wednesday at 5pm. Treatment will be from May 27th until September 2nd
- Trimmed west and east beach trees

- East Beach Lighting repair
- Replaced Lifeguard signage on Lifeguard towers
- Shower nozzles repaired

Parks:

- Have begun xeriscape at the West Beach parking lot islands. Nonfunctional turf
- Continuing irrigation adjustments, Meadowlark park pump stations and replumbing
- Long Acres and Playfair park Tree trimming
- Currently receiving quotes for rodent control.

Equestrian Center:

- Irrigation repairs
- Continue monitoring rodent control at Long Acres Park current traps are humanized traps.
- Tree Trimming
- Westside small arena light, replaced a digital timer

Fishing Areas:

- Adding ventilation to Aerators.
- Adding Thermal Paint to the Lid Aerators
- Continuing Maintenance on all fishing areas

Buildings:

- Fire Extinguisher inspection
- Repaired ice machine in (CB) kitchen
- Repaired electrical issues in (CB) kitchen.
- Leak in kitchen repaired (CB)

- The surveyor is still working on site updates (Association parking lot ADA)
- AC inspection (CB)

The Operations Department is always working diligently on maintaining SVLA's stature as well as keeping up on regular training videos to ensure we are delivering the best service possible. If you ever notice a maintenance related issue or concern around the community, please call the Association Office (@760-245-9756) and we will do our due diligence to correct the issue(s) or concerns.

Happy July! Summer is here. Everything's geared up to the next level during the summer, especially pertaining to the lake.

As the weather continues to warm up, we will be increasing our activity on the lake. This month our weekly lake cleanings we will be cranked up to daily.

We will also be increasing our lake samplings. We have already begun doing our Harmful Algae Bloom (HAB) testings.

We are still waiting for our permit to be issued for the Lake Patrol Office (LPO). County sent some revisions that needed to be made to the architect; so we are waiting for them to review them. Once the permit is issued, things should move quickly and

be wrapped up within 2 weeks.

We have begun to do biweekly inspections on the v-ditches throughout the community. We are hoping to be able to stay on top of these and keep them clear of debris. If you live near a v-ditch and you notice excessive debris, please do not hesitate to let us know so we can address it right away.

We have been doing our best to continue with the weekly lake clean up. If you notice any areas with excessive trash or debris, it is always helpful to let us know. Give the office a call or send an email to maintenance@svla.com.

Another year, another dazzling firework show! It was all hands-on deck to create such a wonderful event. The Code Enforcement Department would like to thank the SVLA Public Safety and Maintenance departments for their support, hard work, and dedication to making the event run smoothly.

The Code team wishes everyone a safe and happy Fourth of July. We would like to remind residents that all Fourth of July decorations must be removed within 30 days or by August 4th. The summer months can be devastating to grass and landscaping. Code Enforcement officers perform inspections for dead/dying lawns and landscaping, so make sure you are watering routinely to avoid a courtesy notice or citation.

One of the most common violations we see around the community is weeds. We recommend that every resident checks their property's landscaping regularly to make sure weeds are not present. As a reminder, code enforcement does not grant extensions for weeds, and all violations must be corrected within two weeks of receiving a courtesy notice or a citation will be sent. Another common violation is residents doing projects without approval from the SVLA Architectural Committee. For any exterior projects or permanent fixtures residents wish to do/add to their properties, free architectural applications are available on the SVLA website or in our office.

Lake and Boating Safety are top priority for Public Safety during the hustle and bustle of summertime...

It's another beautiful day in the desert. The sun is shining, there is a slight breeze, but the temperature is already 97 degrees at 10 a.m. which only means one thing: boating. Spring Valley Lake is the perfect oasis for SVLA residents to enjoy, cool off and have fun during hot summer days.

While residents are out to play, the Spring Valley Lake Public Safety team is hard at work. Lake and boating safety are top priority during the summer season to ensure maximum safety of all residents with minimal interference to their day.

SVLA has set rules and regulations that all residents must follow to use the amenities that this wonderful community provides. By doing so, residents are helping Public Safety Officers ensure their safety and the safety of others. Public Safety feels it is necessary to remind residents of some of these rules. Boating rules and guidelines should be read by all residents before going out on the lake.

All residents are reminded to never drink and operate a vessel. It is the same as drinking and driving and it is illegal. According to SVLA Rules and Regulations,

"Department of Boating and Waterways has determined that alcohol is a high factor of all fatal motorboat accidents in California. Please do not drink and operate a vessel." Please keep in mind that any safety violation can result in immediate citation from a Public Safety Officer.

Residents who have homes on the lake are not allowed to swim past the 16-foot easement from their property. Wind, current, exhaustion and swim experience are very serious factors to be aware of while in the water. Failure to pay attention to these factors could be fatal. However, Public Safety enforces these rules and regulations to help prevent situations like this from happening.

It is important to remember that the speed limit in the main body of water is 35 mph. Boaters need to consider that not everyone will be going the same speed. Boats that are pulling a skier or tuber will be driving at slower speeds. Please keep in mind that faster speeds can equate to less reaction time to avoid other boats or people in the water.

Speeding and creating a wake has been a continuous problem within the no wake zone. Speed-

ing is not allowed and is in no way tolerated within this area of the lake. Boaters speeding within the area could put paddle boarders and swimmers in immediate danger. According to SVLA Rules and Regulations, "Paddle and row boats, kayaks, and canoes shall remain within the "No Wake" areas."

There has been some confusion about the buoys, once a vessel has passed an orange buoy it must reduce speed to avoid creating any sized wakes. Water to the right of the orange buoys and within the channels is considered the no wake zones. Once boaters enter the no wake zone, they will see white buoys that say, "no wake zone". These are here to remind residents that they are currently in a no wake zone. Vessels creating a wake in a no wake zone can also cause damage to the lakefront homes property.

When beaching a boat, be mindful of the wakes that arise from your boat when entering the no wake zone. Those wakes travel and could cause other boat passengers to lose their balance and/or fall into the water and injure themselves. Many boaters wish to enter and exit the beaching area at the same time and there is limited room. Be mindful to remain a safe distance from other boats to be as safe as possible.

Personal watercrafts (PWC), such as but not limited to, jet skis and sea-doo's, have certain restrictions set by California State Boating and Waterways and Spring Valley Lake Rules and Regulations: "Operators will not jump another vessel's wake within 100 feet of the vessel creating the wake, including any other PWC, water skier, or any allowable towed object.

Operators will not drive so fast and close to another vessel that they cause the other operator to swerve at the last minute to avoid collision. PWC operators will not drive towards any person or vessel in the water and turn sharply at close range to spray that vessel or person. PWC operators shall not tow any device or skiers while on Spring Valley Lake."

Public Safety's, Corporal Justin Hartley, advises boaters to go through a pre operation check list before going out on the lake. The vessel inspections list can double as a pre operations check list to make sure your boat is fully prepared for any situation that may occur while on the lake. Hartley said, "Every vessel out on the lake is subject to be stopped for a random safety inspection. Even if you are following lake rules, you may be stopped for this inspection. "Additional recommended equipment that is beneficial to have while boating on the lake: a paddle, bucket/pump, first aid kit, and throwable buoy.

It is required that all boats are equipped with functioning front and back navigation lights. According to the SVL Rules and Regulations, "Navigation lights must be kept in serviceable condition and displayed in accordance with the "Rules of the Road" between sunset and sunrise and at other times of restricted visibility."

Thank you for your attention towards these important matters. The Public Safety Department looks forward to working with all residents to maintain proper lake and boating safety. Prioritizing the health and safety of our community will ensure another wonderful summer in the jewel of the desert.

Originally named the SVL Fishing Club, began its journey in January, 1984 by a few property owners who enjoyed fishing and sharing their catch during pot luck get togethers at their homes. Soon, a president was chosen and a club had begun.

This was before the Community Center was built, and so meetings took place in several different venues, including the Equestrian Club House. The first club President was Art Keimig. The VP was Jack Arringdale. There were many Presidents over the forty (40) years of the club's existence. In all, there were 31 Presidents, some serving more than one or even more than two years.

The first club leaders voted to accept By-Laws and fishing derby rules. The intent of the Fishing Club was to promote a friendly fishing experience and social activities. Over the years, the club was known for its fun fishing derbies, bus trips, golf tournaments, bingo nights, and bocce ball tournaments. The club was open to all members of the Association

and their family members. I was the publicist for over 19 years, sending out a monthly club newsletter to club members and submitting articles in the community Breeze.

The Fishing Club members voted to update the club name to SVL Social & Fishing club in 2011 in order to promote community members to join who did not fish the lake. Eventually, dropping 'fishing' altogether.

This very successful club boasted 275 members over the ten years from its inception. You had to make reservations via the club Secretary in order to be in compliance with the maximum number allowed in Meadowlark Hall. The Fishing Club was the only social outlet in Spring Valley Lake at the time, and the community was hungry for social events that did not require joining the country club.

Deciding it was time for the club to end its long journey was a tough call. But in the end, it was the right call. We have many great memories and stories to tell and the friendships that were formed will remain forever. Until Next Time.
