#### Guidelines For Board Of Directors Elections

The Bylaws of the Spring Valley Lake Association and the State Corporations Code give wide latitude to the Board of Directors in establishing procedures for the conduct of elections.

In summary the Bylaws dictate that:

- (a) The annual elections meeting be held on the last Saturday of each April.
- (b) That four Board seats are up for election in even numbered years; three seats in odd numbered vears.
- (c) That members serve for two year terms and may only serve for two consecutive terms.
- (d) That the only qualification for members of the Board is that they be voting members (property owners.)

The Corporations State Code, Section 7614, dictates that the Board appoint either one or three Inspectors of Election. Their duties are as follows: "The inspectors of election shall determine the number of membership outstanding and the voting power of each, the number represented at the meeting, the existence of a quorum, and the authenticity, validity and effect of proxies, receive votes, ballots or consents, hear and determine all challenges and questions in any way arising in connection with the right to vote, count and tabulate all votes or consents, determine when the polls shall close, determine the result and do such acts as may be proper to conduct the election or vote with fairness to all members."

In addition to the foregoing, the following guidelines will be used in Spring Valley Lake Association elections.

(a) In order to become a candidate for the Board, potential nominees must submit a letter of intent to the Board of Directors. Letters of intent must reach the Association office by close of business on the business day nearest February 15th of each year.

- (b) Approximately 7 to 10 days after the filing deadline the Board will sponsor a seminar for announced candidates. The seminar will include information on board responsibilities, legal liabilities, conflicts of interest, amount of time consumed by board membership, etc.
- (c) Candidates may withdraw by furnishing written notice to Association offices. Candidates will be notified at the seminar of the approximate date which ballot materials will go to the printers. They will be encouraged to withdraw by that date if at all,
- (d) Write-in candidates and nominations can be accepted from the floor once a quorum has been established.
- (e) At its March meeting the Board of Directors will select as record date for the purpose of determining which persons are qualified members entitled to notice of the election meeting and those entitled to vote at the meeting.
- (f) It is the Board of Directors policy that incumbent directors will be listed first on the Notice of Meeting and proxy. Subsequent will be candidates listed alphabetically in last name order.

Persons entitled to vote and persons entitled to serve on the Board of Directors are members as defined in the Covenants. Conditions and Restrictions of record as of the date of record chosen by the Board of Directors. A person serving on the Board of Directors shall remain a member of the Association as defined in

the CC&Rs during their entire to normal Breeze advertising term as a Board member in order to so serve. Prior to the election and before publication in the Breeze the Board shall require appropriate proof of a candidate's membership status in the Association. The Board of Directors decision as to whether such proof is adequate shall be binding and a failure of a candidate to satisfy the Board shall cause that person's name to be removed as a qualified candidate.

Notice of the meeting and election materials will be mailed out on or about the record date, to persons who are registered with the Association as members on the record date.

- (g) Election materials will be prepared by the Administrator with Board approval and sent to the Association's general counsel for review prior to printing.
- (h) A "Meet Your Candidates Forum" will be held prior to each election. Normally, the forum will be held in early April of each year. A moderator will be selected by the Board to conduct the Forum. The moderator, subject to reasonable review by the Board of Directors, will, however, provide information to all candidates alike as to the format and questions to be used. If any current members of the Board of Directors are candidates they will abstain from the review.
- (i) Each candidate will be provided with an opportunity to present a campaign statement of up to 350 words to be published in the April Breeze. A recent photograph approximately 2" x 3" will also be accepted for Breeze publication.
- (i) Candidates and/or their supporters may advertise in the Breeze at the normal Breeze advertising rates and subject

- deadlines. At least one property owner's name must appear as the ad's sponsor. The ads will not be a source of attack against a fellow candidate or member of the Spring Valley Lake Association.
- (k) Candidates or their supporters may not utilize the Breeze Letters to the Board at any time. No article will be used to support any particular announced Board candidate. The President will monitor to ensure that this does not happen, especially during the March and April editions of the Breeze.
- (I) Mailing lists/labels available to board candidates and their supporters in accordance with release of information guidelines published separately.
- (m) The actual conduct of the election will be as determined by the Inspectors of Election. The Administrator will provide administrative and logistical support for the election, as directed by the Board of Directors.
- (n) A committee of three property owners is appointed by the Board at the annual election and budget meeting to review and report to the Board on the adoption with corrections, if any, of the annual meeting minutes at the next regularly scheduled meeting of the Board.

# 2018 Vessel Registration

#### Vessel Stickers are valid from January 1, 2018 to December 31, 2018. All vessels must be re-registered each year.

Vessel registration will begin January 2nd, 2018. Vessels can be registered from 7:30 a.m. until 5:30 p.m., Tuesday through Friday.

All NON-POWERED vessels (kayaks, canoes, paddle hoats etc.) as well as POWERED vessels must be registered prior to entering the lake. If any vessel found on the lake is not registered, the owner will be cited and fined per vessel in the water.

The following requirements are necessary to register your vessel with the Association Office.

#### VESSEL REGISTRATION REQUIREMENTS:

All Documents (DMV Reg., V.O.P., Ins.) MUST list the same Homeowner/Tenant Member's name. The Association office will need copies of the following: V.O.P., Driver's License, DMV Registration, Insurance, Safety Inspection and Signed Conditions form.

- 1. Yearly safety inspection. All powered vessels must pass a safety inspection by our Public Safety Department. You may call and schedule an officer to come to your home or bring the vessel directly to the launching ramp. Please remember to make an appointment prior to bringing the vessel to the marina. Other than sailboats, all non-powered vessels do not require a safety inspection. The inspection will include a review of the following:
  - Current DMV registration, listing the hull number, make and model of the vessel
  - State registration numbers properly displayed with certificate number when applicable
  - Sound signal devices, visual distress signals, lights, ventilation systems, flame arrestors, water ski flags, fire extinguishers, and personal flotation devices
  - Inspections will include check for Quagga Mussels
  - Please contact the Public Safety Department at 760-245-6400 with any questions
- 2. Current Driver's License listing the HOMEOWNER or TENANT Member's name.
- 3. Current SVLA Operator's Permit. An operator's permit is required for all Homeowners, Tenant Members, and their guests driving powered and non-powered vessels. The Public Safety Department administers the test daily at 9 a.m., in the Community Building. Study guides are available at the Association Office and online at www.syla.com.

- 4. Current State DMV Registration. The registration must include the homeowner's or associate member's name and address.
- 5. Current insurance policy.
  - · Powered vessels must provide the following:
  - a. Name of the homeowner or tenant member
  - b. Policy number
  - c. Policy period must include beginning dates
  - d. Vessel hull and CF number
  - Spring Valley Lake Association <u>must</u> be listed as additional interest

- g. \$300,000 minimum liability
- Non-powered vessels <u>must</u> provide the following on homeowners policy:
- a. Name of the homeowner or tenant member
- b. Policy number
- c. Policy period must include beginning dates
- d. Spring Valley Lake Association <u>must</u> be listed as additional interest with mailing address

- f. \$300,000 minimum liability
- SVL Staff members cannot inquire for you.

Insurance companies will **ONLY** provide information about individual policies to policy holders.

- 6. Payments and stickers. Payments are taken and stickers are issued after all the above requirements are met:
  - Non powered vessels \$0.00
  - Powered vessels 15 horse power and under \$45.00
  - Powered vessels over 15 horse power \$150.00

#### Vessel Stickers are not prorated.

For any questions, regarding the above information please contact the Association office at 760-245-9756. Our goal is to make this process as easy and convenient as possible for all homeowners/tenant members. Please register your vessels early and take full advantage of our beautiful lake.

**Friday is our busiest day for boat registrations.** So please consider an alternate day to save both waiting time and frustration. If you call our office prior to registering a vessel, we will gladly provide you with a personalized list of requirements.



During the colder months, the Public Safety Department receives many calls regarding water leaks due to broken sprinkler pipes. If the temperature of your pipes drops below 32 degrees, even for a short period, you run the risk of a pipe fracture or worse. Underground sprinkler piping is usually insulated from freezing temperatures by soil. Valves and piping that supply water to them are generally above ground and are the most likely places to find a leak. Try these suggestions to minimize your chances of a broken pipe:

· If you have an automatic sys-

#### 2018 Vessel Registration

Starting January 1, 2018, all Spring Valley Lake residents that have a vessel on the lake are reguired to renew their SVLA vessel registration. This includes all powered and non-powered vessels. The Public Safety Department will be out on the lake in January checking all vessels that are not registered and issuing a tem then you can "shut down" the controller (timer). Most controllers have a "rain mode" which simply shuts off the signals to the valves.

- · Disconnect and store garden hoses. If your home has a separate shut-off for external faucets, turn it off and drain the water from those faucets.
- · Above ground piping needs to be insulated. Self-sticking foam insulating tape or foam insulating tubes are commonly found at home supply stores and are relatively inexpensive.
- If you have a gardener or a lawn service company, talk to them about winterizing your above ground irrigation pipes.

If you are out in the community and notice a water leak at a property, please report it to the Public Safety Department (760 245-6400).

courtesy notice as a reminder. If you do not want to register your vessel in January, you can remove your vessel from the lake to avoid a citation. When you are ready for a vessel inspection please call the Public Safety Department at (760) 245-6400 to set up an appointment time. Please remember that once you receive your new 2018 SVLA stickers,

you need to place them on your vessel.

To aid in preparation for the vessel inspection, we have included the following checklist for vessel owners:

#### **Powered Vessels**

- · Current Vessel Operator Permit (VOP)
- · Current and valid state registration indicating the appropriate member as the registered owner.
- · State registration numbers and hull identification numbers must be displayed properly and unobstructed.
- Vessel must be maintained in a working order (motor and structural efficiency).
- · Navigation and anchor lights must be in working order. (PWC excluded)

hand-held air horn, whistle, Etc.)

- · Flame arrestor properly installed. (PWC excluded)
- · Serviceable fire extinguisher filled to appropriate levels.
- · Red/orange ski flag. (PWC excluded)
- · Throwable personal floatation device. (PWC excluded)
- · USCG approved life jacket for every persons allotted by max capacity.
- · Ventilation or 'blower' must be in working condition. (PWC excluded)

SVLA R&R 5.2.2. All vessels must have current State and Spring Valley Lake registration decals before being placed on the lake.

SVLA R&R 5.2.5. Boat registrations are valid from January 1st • Sound device (built-in air horn, to December 31st of each year.

Where does all the time go? When you're young it seems like one has forever, but as the years pass and the older one becomes, it seems like time passes very quickly...Strange how that happens.

we will start to inspect homes for any decorations that might still be up. Remember they can only be up for 30 days after the holiday. We know it's much easier to just leave them up for next year and not have to go through all the trouble of packing them away in the garage. Please just humor us and take them down until next year, so we don't have to send out lots of notices.

pressure about your trash cans? We're not going to stop sending notices until they are put where they belong! If you can set them in front of your gates, then you can put them behind your gates. For those of you that leave them in the streets, this is a real problem. You will get written

up every time. Until this issue be-

comes under control, notices and citations will continue to be writ-

We still see exterior modifications and new jobs being done without any Architectural Proj-

ect Applications being submitted. Please remember that failure to do this is a \$1,000 fine. It only takes a few minutes to fill out the application and submit it into the Association office. Eddie Vindas, the liaison to the Architectural Committee, will help you with any of your architectural questions. For landscaping projects you must have 30% greenery, 1 tree, a drawing with dimensions, and a small rock sample (if applicable), and list any plants on the drawing. When your application has been approved, you have 6 months to complete your project. This is so much easier than the fine.

What is the difference between Public Safety and Code Enforcement? Some do not know the answer.

#### **Public Safety:**

- 1. Is available 24 hours / 7 days a week.
- 2. Are first responders in answering medical calls.
- 3. Goes to most Animals calls
- 4. Responds to almost any call that comes into dispatch.
- 5. Enforces all applicable SVL and Regulations Rules

CC&Rs.

- 6. Will respond to suspicious vehicle or person checks.
- 7. Provides well checks when requested to do so.

#### **Code Enforcement:**

- 1. Inspects the exterior of all homes and lots.
- 2. Submits all Architectural Applications to the Architectural Committee for approval.
- 3. Submits citations to the Citation Review committee for review and then to the Board for a final decision.
- 4. Issues notices to Homeowners for Code Violations.

5. Enforces the governing documents pertaining to properties.

These are just some of the differences between the two groups. The four Code officers do not wear uniforms, and their cars are now different than those of Public Safety.

We hope everyone has a wonderful month and a great start on the New Year!!! Let this be a new beginning of a wonderful adventure. Let's all try working together to make this a marvelous community in the High Desert.






