- 1. The information should pertain solely to the interests that the recipients/readers have as members and residents of the Association.
- 2. The information shall not contain any personal attacks against, or criticisms of, any person affiliated with the Association, including but not limited to members of the Association's management, Board, or Committees.
- 3. The information shall not contain any information which is political in nature, or which communicates or expresses an opinion or position regarding any pending Association ballot

measure (i.e., any pending Director election), unless published as a candidate statements or ad space purchased for campaign purposes.

The Association's editor/media coordinator and General Manager have sole discretion with regard to the content of the Newsletter. Approval submissions must be received by the deadline date (the 1st of each month) to be included in the Newsletter.



2020 VESSEL REGISTRATION

Starting January 1st 2020, all Spring Valley Lake residents that have a vessel on the lake are required to renew their SVLA vessel registration. This includes all powered and non-powered vessels. The Public Safety Department will be out on the lake in January checking all vessels that are not registered and issuing a courtesy notice as a reminder. If you do not want to register your vessel in January, you can remove your vessel from the lake to avoid a citation. When you are ready for a vessel inspection, please call the Public Safety Department at (760 245-6400) to set up an appointment time. Please remember that once you receive your new 2020 SVLA stickers, you need to place them on your vessel.

To aid in preparation for the vessel inspection, we have included the following vessel inspection checklist for vessel owners:

Powered Vessels

- Current Vessel Operator Permit (VOP)
- Current and valid state registration indicating the appropriate member as the registered owner.

- State registration numbers and hull identification numbers must be displayed properly and unobstructed.
- Vessel must be maintained in a working order (motor and structural efficiency).
- Navigation and anchor lights must be in working order. (PWC excluded)
- Sound device (built-in air horn, hand-held air horn, whistle, etc.)
- Flame arrestor properly installed. (PWC excluded)
- Serviceable fire extinguisher filled to appropriate levels.
- Red/orange ski flag. (PWC excluded)
- Throwable personal floatation device. (PWC excluded)
- USCG approved life jacket for every persons allotted by max capacity.
- Ventilation or 'blower' must be in working condition. (PWC excluded)

SVLA R&R 5.2.2. All vessels must have current State and Spring Valley Lake registration decals before being placed on the lake.

SVLA R&R 5.2.5. Boat registrations are valid from January 1st to December 31st of each year.
