



Vessel Registration

Vessel Stickers are valid from November 1 – October 31 of each year.

All vessels must be re-registered each year.

Vessels can be registered from 7:30 a.m. until 5:30 p.m., Tuesday through Friday. All **NON-POWERED vessels** (kayaks, canoes, paddle boats etc.) as well as **POWERED vessels** must be registered prior to entering the lake. If any vessel found on the lake is not registered, the owner will be cited and fined for each vessel in the water. The following requirements are necessary to register your vessel with the Association Office.

VESSEL REGISTRATION REQUIREMENTS:

All Documents (DMV Reg., V.O.P., Ins.) **MUST** list the same Homeowner/Tenant Member's name. The Association office will need copies of the following: V.O.P, Driver's License, DMV Registration, Insurance, Safety Inspection and Signed Conditions form.

1. Yearly safety inspection. All powered vessels must pass a safety inspection by our Public Safety Department. You may call and schedule an officer to come to your home or bring the vessel directly to the launching ramp. Please remember to **make an appointment prior to bringing the vessel to the marina**. Other than sailboats, all non-powered vessels do not require a safety inspection. **The inspection will include a review of the following:**

- Current DMV registration, listing the hull number, make and model of the vessel
- State registration numbers properly displayed with certificate number when applicable
- Sound signal devices, visual distress signals, lights, ventilation systems, flame arrestors, water ski flags, fire extinguishers, and personal flotation devices
- Inspections will include check for Quagga Mussels

2. Current Driver's License listing the HOMEOWNER or TENANT Member's name.

3. Current SVLA Operator's Permit. An operator's permit is **required** for all Homeowners, Tenant Members, and their guests driving powered AND non-powered vessels. You take the test online at www.svla.com. Click on **Departments**, click on **Public Safety**. Contact Public Safety when completed for results. Study guides are available at the Association Office and online. Public Safety will need your current Driver's License and your SVL member card to issue a V.O.P.

4. CA Boater Card. Available on the state website, www.californiaboatercard.com. Required by the state of CA and now required on our lake for all powered vessel operators regardless of age.

5. Current State DMV Registration. The registration must include the homeowner's or associate member's name and address.

6. Current insurance policy.

- **Powered vessels must** provide the following:
 - a. Name of the homeowner or tenant member
 - b. Policy number
 - c. Policy period **must** include beginning dates
 - d. Vessel hull and CF number
 - e. Spring Valley Lake Association **must** be listed as

Additional Insured or Additional interest

g. \$300,000 minimum liability

- **Non-powered vessels must** provide the following on homeowners policy:

- a. Name of the homeowner or tenant member
- b. Policy number
- c. Policy period must include beginning dates
- d. Spring Valley Lake Association **must** be listed as
- Additional Interest** with mailing address
- SVLA correct mailing address: 7001 SVL Box, Victorville, CA 92395
- f. \$300,000 minimum liability

- **SVL Staff members cannot inquire for you.**

Insurance companies will **ONLY** provide information about individual policies to policy holders.

7. Payments and stickers. Payments are taken and stickers are issued **after** all the above requirements are met:

- Non powered vessels \$0.00
- Powered vessels 15 horse power and under \$75.00
- Powered vessels over 15 horse power:
 - 1st Vessel \$200 • 2nd Vessel \$150 • 3rd Vessel \$100

Vessel Stickers are not prorated.

VESSEL WEIGHT & LENGTH REQUIREMENTS:

Any vessel registered is restricted to a weight limit of 7500 pounds, (Dry published weight plus dry maximum ballast weight cannot exceed 7500 pounds). Pontoon boats cannot exceed 24ft in length; all other vessels cannot exceed 22ft.
