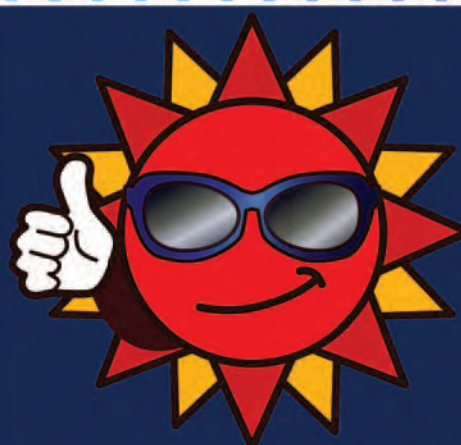

Lake & Community Update

Floating Island Relocation

The Association would like to inform our community that the Board of Directors has approved the relocation of the floating islands to the Marina area. This move will allow staff to monitor the islands more efficiently, maintain them more safely, and ensure the vegetation remains healthy throughout the year.

Residents and visitors may notice that the islands are no longer in their previous locations around the lake. Their relocation is part of our ongoing efforts to improve environmental management and create more sustainable lake conditions. We appreciate everyone's patience and understanding as this transition continues.

Lake Planning and Water Quality Efforts

Our Operations Team is hard at work preparing for next year's carefully managed lake-lowering project. This is a major effort that requires detailed planning, and staff are currently completing a full lake-mapping process. This includes depth measurements and shoreline assessments that will guide the project once work begins. We anticipate having the full map finalized by the beginning of the new year.

Water quality continues to be a priority. On November 18, members of the Lake Commit-

tee met with representatives from Lahontan to review current concerns and discuss potential long-term solutions. This open dialogue helps ensure that we remain aligned with environmental regulations while exploring ways to steadily improve lake conditions.

Following this meeting, the Lake Committee developed a tentative plan to meet with the Bear Valley Country Club to discuss shared watershed goals. This collaboration is intended to strengthen water-quality efforts, improve stormwater practices, and establish long-term strategies that benefit the entire community.

Residents can expect regular updates as these important projects progress.

Trout Stocking Season Has Begun

We are happy to share that the winter fishing season is officially underway! On November 20, the lake received a fresh stocking of 1,000 pounds of trout from our trusted local supplier, Jess Ranch Hatchery. This annual tradition brings excitement to anglers of all ages and helps maintain a strong fish population through the winter.

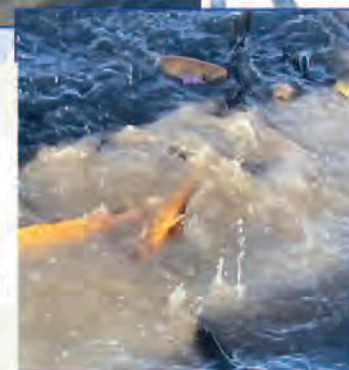
Additional trout deliveries are scheduled throughout December, with another stocking planned for January. Exact delivery dates

CODE ENFORCEMENT

As the holiday season approaches, our community begins to sparkle with lights, decorations, and festive gatherings. This is one of the most enjoyable times of the year here in Spring Valley Lake, and we appreciate the effort everyone puts into making our neighborhood shine.

To help ensure that we maintain both safety and community standards, please take a moment to review a few important reminders about common violations and guidelines that tend to come up during the Christmas season:

First, we love to see creative displays, but please remember that decorations must be removed by 01/25/2026 and any remaining Halloween decorations should have been removed by 12/1/2025. If you have roof or high-elevation decorations they need to be installed safely—no unsecured extension cords or items that could blow off in wind. Holiday gatherings mean extra boxes, wrapping paper, and packaging. So please be cognizant of your neighbors when filling your trash cans so they do not overflow into the street. We understand families host visitors this time of year, but please remind guests not to block driveways, mailboxes, or fire

lanes. Please remind your guests not to park on grass, rocks, or other unimproved surfaces during their stay. RVs or trailers (including those used for light displays) are not permitted to remain parked in driveways or on the street overnight.

Wishing you all a safe, joyful, and peaceful holiday season. If you have any questions about seasonal guidelines, please contact the Code Enforcement Department.

Residents of Spring Valley Lake, The holiday season is upon us, and shopping online continues to be one of the most convenient ways to find the perfect gifts. As you prepare for package deliveries, please keep the following helpful tips in mind:

- If your package is scheduled to arrive while you are away, consider contacting the delivery company to request pickup at an authorized facility or re-schedule the delivery for a different date.
- If the delivery company cannot meet your request, ask a trusted neighbor, friend, or family member to retrieve the package once it has been delivered to your doorstep.

If you have exhausted all other options and still require assistance, you may call the Public Safety Department at **760-245-**

6400. A Public Safety Officer can bring your package to the Community Building, where you may pick it up.

Please remember that this service is a last resort. The Public Safety Department has limited space and cannot hold packages for more than 24 hours. Additionally, if a package is too large or heavy to be moved safely, we may be unable to assist.

Packages will be released only to the owner, who must present a valid photo ID that matches the name on the package.

This is a special courtesy provided by SVLA during the holiday season only. SVLA will not be responsible for any damages that may occur.

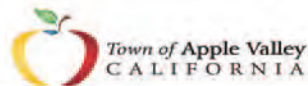

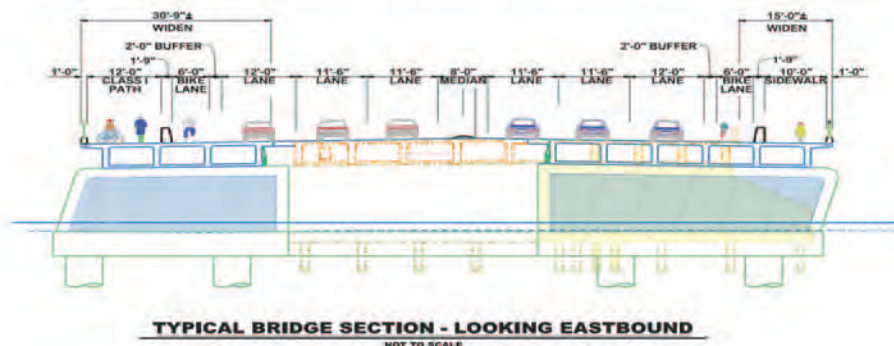

The Spring Valley Lake Municipal Advisory Council Important Update



BEAR VALLEY ROAD BRIDGE over the Mojave River Rehabilitation Project



What's Being **PLANNED**

The Town of Apple Valley, in partnership with Caltrans, is improving the Bear Valley Road Bridge over the Mojave River.

The project includes:

- Widening the bridge to six lanes with a center median
- Adding bike lanes, a protected sidewalk (south side), and a protected multi-use path (north side)
- Improving roadways from Mojave Fish Hatchery Road to Jess Ranch Parkway

Other upgrades:

- Relocating Southern California Edison power lines
- Replacing a water line across the river
- Installing a drainage pipe on Outer Bear Valley Road
- Building a water-quality basin northwest of the bridge
- Adding southbound turn lanes at Bear Valley Road and Fish Hatchery Road

The bridge is located in Apple Valley, with the west approach in Hesperia and Victorville.

What to **EXPECT** During Construction

Residents and travelers may experience:

- Temporary lane closures and traffic shifts
- Utility shutoffs (announced by utility companies)
- Noise, dust, and construction activity during weekdays
- Occasional night work to reduce daytime impacts
- Pedestrian and vehicle detours as needed

Estimated **SCHEDULE**

- Construction begins: December 2025
- Water line replacement: February–March 2026
- Traffic shift south: Spring 2026
- Stormwater pipeline installation: Summer 2026
- Power line relocation and power shutoff: October 2026
- Traffic shift north: Spring 2027
- All lanes open: Spring 2028

Dates are estimates and may change once the contractor finalizes the schedule.

Estimated **COST & FUNDING**

Total estimated cost: \$53.5 million
(Funding includes construction, management, and engineering)

Funding sources:

- Federal Grants (Highway Bridge Program, Carbon Reduction Program): \$43.4 million
- San Bernardino County Flood Control (A.R.P.A.): \$540,000
- San Bernardino County Transportation Authority: \$3.8 million
- Active Transportation Program: \$232,000
- Town of Apple Valley and Cities of Victorville & Hesperia: \$4.8 million

The Lake Committee recently received questions regarding our Coving Repair Project Plan which we introduced to the community back in November of last year. It became obvious to us that there was much incorrect information circulating and we felt perhaps it was time to begin communicating more about our plan, even though back in April the Board had pushed this project out to late in 2027-2028.

A very wise individual recently reminded us that *if you don't tell your story---someone else will...*

And this is what has happened. Well-meaning residents, those who have volunteered countless hours in this community, misunderstood not only where this project was in it's forward progress, but also how this project would be executed and funded.

So, let's break this down a bit for everyone to better understand all of this.

1) What our project is: Our Coving Repair Plan is responsive to a prior SVLA Board directive to create and implement an ongoing shoreline repair maintenance plan. This Board directive was required by a 1997 Court decision where the Spring Valley Lake Association was found to be responsible for a homeowner's property damage due to shoreline degradation.

Our Coving Repair Project plan will center around using an alternative concrete forming product called a Geocell Grid. This geo-synthetic

fabric grid was developed by the US Army Corps of Engineers back in the early 1980s and has been used for everything from building roads to slope stabilization to hard armoring of water channels.

The Geocell Grid provides a much faster method of concrete forming than traditional wood and rebar and will allow work to proceed at a much-accelerated pace, saving time and labor costs.

The grid creates a flexible hard armoring and will keep concrete sections intact. The addition of footings at the base of each coving, as recommended in the 2023 Genterra Consultants Report, will further prevent undermining, erosion and slippage. With the coving being underwater and exposed to the constant wave and wake energy, this is crucial.

There are at least 3 companies that manufacture this grid product and we have spoken with in-house engineers at all three. They all agreed that this would be an excellent way to accomplish our coving repair and that concrete work using this Geocell Grid would hold up for years and years to come.

2) Where we're at now: Back on April 22nd our Board made a decision to push this coving repair plan to late 2027-2028. Because that now put us 2 1/2 years out, we took a step back from pursuing a Request For Proposal (RFP) which would include contractor bid solicitation, vetting and selection. The late 2027-2028 commencement signaled to our committee that we should push "pause" until next year (2026) and then restart that RFP process. The Board had also decided that there would be a lake lowering in 2026, but only to further assess the condition of the shoreline.

While we believe the 2023 Genterra Consultants shoreline survey and report had already well documented this damage, we respect the Board's decision to proceed slowly.

3) Where we're heading next: Although we have previously consulted with several engineers, our next steps are to consult with another engineer to more formally confirm the use of the Geocell Grid as a structurally superior, time and cost-effective method to achieve our long-term coving repair goals. We have been told that repairs utilizing this Geocell grid and concrete with a high 3600 psi (pounds per square inch) concrete mix could last 100 years or more.

We will also start preparing for the Request for Proposal process and will invite contractors to view our lake coving damage when the water level is lowered in late 2026.

During this initial lowering, we proposed to the Board that perhaps we could do a large portion of our lots on the main lake, working within a budget which was \$1.2M and roughly 25% of our overall project estimate. This is a Reserve Item and there is approximately \$2M now in Reserves. But the Board was not comfortable with this amount for what they see as a "test method" of repair. We are willing to scale that budget request back to a number they are more apt to agree to. Our mission is to now put their minds at ease with the additional information they require to get to a "yes" on this repair method and at whatever scale.

4) What we will not be pursuing: It is not our desire to fund these repairs in any manner that would result in an increase of HOA dues, a one-time special assessment, nor an assessment over time. While it is

physically possible to do the entire shoreline repair in one lake lowering, we do realize it may not be *financially* possible. So, we can segment this project and spread it out over time if necessary. This sounds good right? We think so!

5) What we will be pursuing: It is our intent to hold a Town Hall dedicated to re-introducing our project to our community as well as providing an opportunity for any questions you may have. We are hoping to have an engineer participate remotely to engage with our residents as well. This will likely take place very early next year; and we will provide ample notice to get maximum attendance and participation.

In closing, we apologize for "pausing" this project without providing an explanation as to why we had paused. This void left a vacuum which allowed much incorrect information to circulate throughout our community, and I think we can take some ownership of that.

Spring Valley Lake is a wonderful place to call home, and we all enjoy the benefits of living in a community that is homeowner governed and served by a constant flow of volunteers who step up to make a positive difference in all that SVL has to offer. We've all heard the term before, *"We're better together"*. We, on the Lake Committee, believe it's true. Please plan on being a part of our efforts moving forward, as we put the next pieces of the plan in place for our Coving Repair Project.
