



# SAFETY INSPECTION REQUIREMENTS

**Please Call Public Safety to Schedule a Safety Inspection: (760) 245-6400**

---

- Vessel Inspections must be done prior to submitting your paperwork to the Association Office
- Have your VOP and Current Registration at the time of inspection
- Vessel measurements will not include the swim steps
- CA Boater Cards are now required for all vessel operators on our lake; visit [www.CABoaterCard.com](http://www.CABoaterCard.com) for more information.

## **Sailboats and manually propelled vessel requirements:**

---

### **Vessels less than 16 feet in length:**

- One (1) type I, II, III or V coast guard approved personal flotation device of suitable size for each person on board.

### **Vessels 16 and over, except canoes and kayaks:**

- One (1) type I, II, III or V coast guard approved personal flotation device of suitable size for each person on board.
- One (1) type IV throwable personal flotation device.
- Sound signal device

## **Power vessels less than 16 feet requirements:**

---

- One (1) type I, II, III or V coast guard approved personal flotation device of suitable size for each person on board.
- One (1) type B-1 coast guard approved fire extinguisher
- Sound signaling device
- Inboard engine operable exhaust fan
- State Registration Stickers must be properly displayed
- Must present your State Registration Certificate at time of inspection
- Navigational lights must be properly working

Please note: Vessels with inboard gasoline motors which are not exposed to the atmosphere above the level of the gunwale must have these additional items: Backfire Flame Arrestor, Muffling System and Ventilation System.

## **Power vessels 16 feet to 22 feet (24 feet for pontoon boats) requirements:**

---

5.2.7.1 Power vessels and sail boats may not exceed 22 feet Maximum length.

5.2.7.2 Pontoon vessels may not exceed 24 feet maximum length.

- One (1) type I, II, III or V coast guard approved personal flotation device of suitable size for each person on board.
- One (1) type IV throwable personal flotation device.
- One (1) type B-1 coast guard approved fire extinguisher
- Sound signaling device
- Inboard engine operable exhaust fan
- Visual distress signal (Flag)
- State Registration Stickers must be properly displayed
- Must present your State Registration Certificate at time of inspection
- Navigational lights must be properly working

Please note: Vessels with inboard gasoline motors which are not exposed to the atmosphere above the level of the gunwale must have these additional items: Backfire Flame Arrestor, Muffling System and Ventilation System.

### **Vessel Weight Limit:**

Any vessel registered is restricted to a weight limit of 7500 pounds. Official manufacturers' specifications will be used to determine the weight of the vessel. (*Dry published weight plus dry published maximum ballast weight not to exceed 7500 pounds.*)

### **Recommended Additional Equipment:**

- Paddle or oar
- Bailing device (pump, bucket, etcetera)
- First aid kit
- Towing line
